Your civil documents **MUST** be issued by the official issuing authority in your country. Please refer to the Document Finder to learn about the civil document requirements for each country.

After you collect the financial evidence

An Affidavit of Support, also called the Form I-864, is a document an individual signs to accept financial responsibility for the applicant who is coming to live in the United States. The person who signs the Affidavit of Support is also called the “sponsor.”

If NVC determines you have paid the necessary fees, submitted the required immigrant visa application, Affidavit of Support, and supporting documents to NVC, you will receive an email that your case is documentarily complete and NVC

Submit Documents - Travel

Once the NVC receives your affidavit of support form (s) and supporting documents, they will review them for technical completeness and correctness. If any of the form (s) are technically not correct or complete, the NVC will ask the petitioning sponsor to correct and complete the applicable form (s) a second time.

Submitting I-864 (Affidavit of Support) to NVC or USCIS ...

Once your application form is submitted to NVC, choose "Start Now" under Civil Documents. You will see a list of all of the documents you are required to submit for the visa applicant. The list is created based on information you supply in your Form DS-260 visa application form. Click on "Start Now" under Affidavit of Support Documents.

Form I-864, Affidavit of Support under Section 213A of the INA, is a contract an individual signs agreeing to use their financial resources to support the intending immigrant named on the affidavit. The individual who signs the affidavit of support becomes the sponsor once the intending immigrant becomes a lawful permanent resident.

Also include a copy of each and every Form 1099, Schedule, and any other evidence of reported income.
