BANKRUPTCY (SCOTLAND) BILL - Scottish Parliament

Bankruptcy (also known as sequestration in Scotland) is the legal process by which you are formally declared insolvent. This means you can't pay your debts as they become due. To be made bankrupt, a sheriff court has to issue a bankruptcy petition against you. This can happen for two reasons:

The 1985 Act was amended by the Bankruptcy (Scotland) Act 1993 and on 1 April 2008, part 1 of the Bankruptcy and Diligence etc. (Scotland) Act 2007 came into force making significant changes to some aspects of bankruptcy in Scotland. Changes included the introduction of LILA, a route into bankruptcy for people with low income and low assets.

Bankruptcy in the United Kingdom is divided into separate local regimes for England and Wales, for Northern Ireland, and for Scotland. There is also a UK insolvency law which applies across the United Kingdom, since bankruptcy refers only to insolvency of individuals and partnerships. Other procedures, for example administration and liquidation, apply to insolvent companies.
